Greg / Dan:

The National Archives alerted me that they cannot account for a 2 terabyte hard drive containing electronic records from the Clinton administration. They last can account for the drive on January 30; they discovered it was missing on March 24 (NARA leadership found out later). They believe it was stolen. NARA has an identical copy of the drive, which it is analyzing.

Two terabytes is a very very large amount of data; the drive may contain a wide range of memos, emails, and other electronic documents from the Clinton White House. All the material is unclassified, except for three documents which Bill Leary has examined and does not believe present any significant risk. Based on its analysis, NARA believes the drive contains other sensitive material, including:

--There is at least a 50% likelihood that the personal information (including DOB and SSN) of all individuals placed through the Clinton Presidential Personnel Office was on the lost hard drive.

--There is a 90% likelihood that the personal information (including DOB and SSN) of all Clinton WH staff was on the lost hard drive. There is a 100% chance that some of it was on the lost hard drive.

--The three classified documents were authored by Lael Brainard, currently a top nominee for Treasury. Much of her work is likely on the drive. They are almost certainly records from many other White House officials.

# US Army soldier based at Fort Hood is found dead - making him the TWELFTH GI from the Texas base to die in the last two months as investigators probe bizarre cluster of suicides, accidents and fatal fights at the base

The United States Army launched an investigation on Friday into the mysterious death of a soldier who was found unresponsive at his post on the Fort Hood base – the latest in a string of nearly a dozen deaths of soldiers serving in the massive Texas encampment.

Sgt. Alex Mathew Dean Taylor, 23, a soldier assigned to the 15th Military Intelligence Battalion, was found dead while on duty, according to [Stars and Stripes](#).

Taylor had enlisted as an aviation operations specialist.

The army released no information about the circumstances of Taylor's death.

'At this point in the investigative process we do not suspect foul play, but have not completely ruled it out while we conduct a complete and thorough death investigation,' a spokesperson for the Army Criminal Investigations Command said.

Taylor was a decorated soldier, having earned numerous commendations during his service, including the Army Commendation Medal, Army Good Conduct Medal, the National Defense Service Medal, the Aviation Badge, and the Air Assault Badge.

A small plane heading towards Libya's coast to monitor migrant trafficking routes for the French government has crashed soon after taking off from Malta's main airport, killing all five people on board.

The twin-prop Fairchild Metroliner banked right and hit the ground, causing a huge fireball, at about 7.20am local time (0520 GMT), video captured by a dashboard camera showed.

Malta's government said all five victims were French and that the flight was part of a French customs surveillance operation tracing routes of illicit trafficking, of humans and drugs, leaving Libya's lawless coasts.

Libya is the main point of departure for tens of thousands of migrants who have been paying smugglers to bring them toward Europe by boat.

Early media reports said the plane had been chartered by the European Union's border control agency, Frontex.

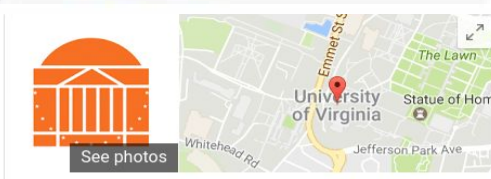

ISTANBUL — The United States formally recognized the rebel leadership in Libya as the country's legitimate government on Friday, allowing the rebel government access to \$30 billion in Libyan assets held in the United States. It is not yet clear how and when the money would be released.

Secretary of State Hillary Rodham Clinton said at an international gathering held to discuss the Libyan conflict that Col. Muammar el-Qaddafi's government no longer had any legitimacy, and that the United States would join more than 30 countries in extending diplomatic recognition to the main opposition group, known as the Transitional National Council.

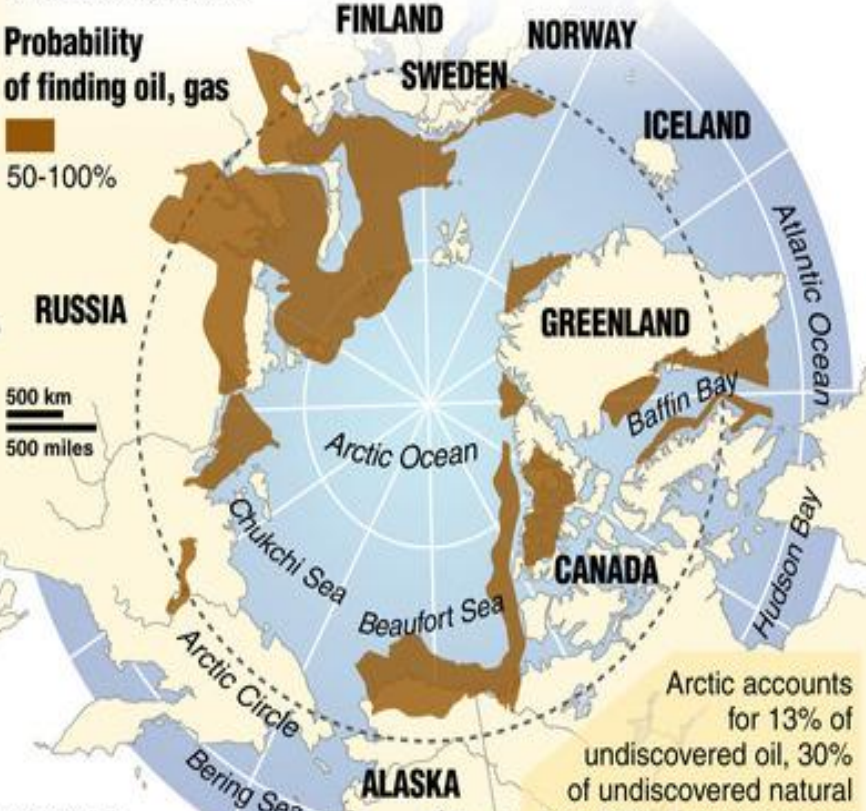

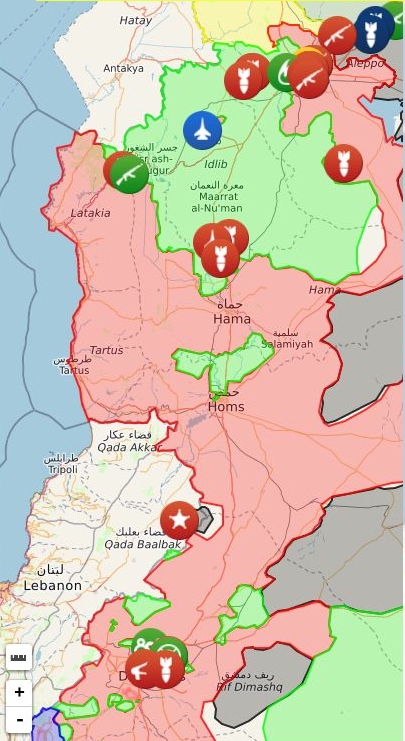

WASHINGTON (AP) — The Justice Department urged a U.S. judge late Friday to keep secret many of the court records in the now-abandoned lawsuit over leaks in the investigation that led to the resignation of former CIA director David Petraeus.

The files include transcripts of sworn interviews with senior Obama administration officials about the sex scandal and its fallout.

Government lawyers said unsealing some of the files "would publicize details of a criminal investigation that concluded without charges being filed." Other records contain or describe confidential statements provided to FBI agents, documents sealed by another court or material that should be kept secret to protect the privacy interests of people connected to the case.

U.S. District Judge Amy Berman Jackson had given the government until midnight to file its objections to unsealing the records. She had noted a 2001 appeals court decision citing "a strong presumption in favor of public access to judicial proceedings."

The case included FBI files and deposition testimony from or about such senior U.S. government officials as Petraeus; Defense Secretary Ashton Carter; former Defense Secretary Leon Panetta; CIA Director Leon Panetta; Homeland Security Secretary Jeh Johnson; Marine Gen. John R. 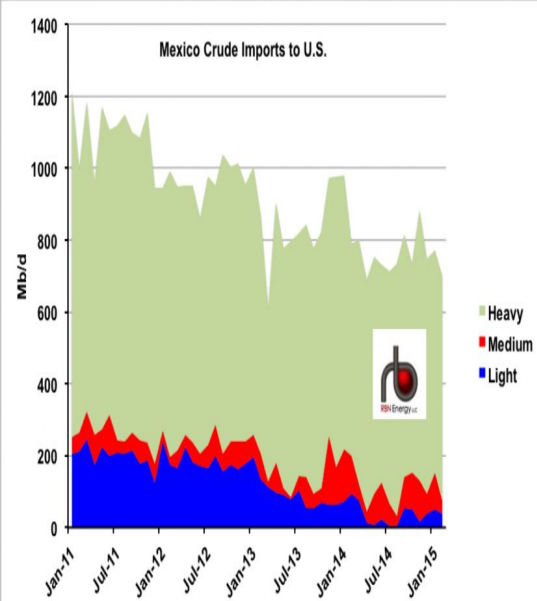
